The investment objective of the International Small Company Portfolio is to achieve long-term capital appreciation.

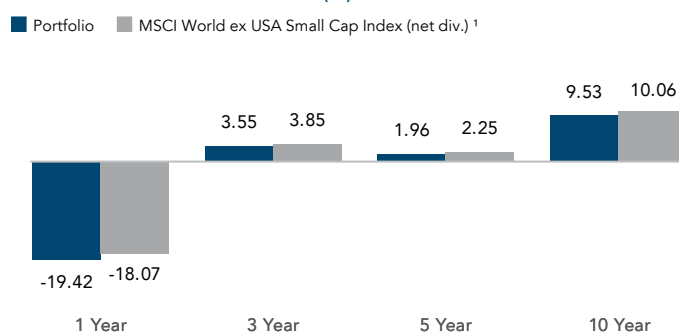
