

We use information in current market prices and company financials to identify differences in expected returns among securities, seeking to overweight securities with higher expected returns based on this current market information. Weighted Average Market Capitalization: The average of the weighted capitalizations of a portfolio's holdings. Weighted Average Book/Market: An average book-to-market ratio resulting from the multiplication of each security's book-to-market by its weight in the portfolio. Weighted Average Profits/Book: An average profits-to-book ratio resulting from the multiplication of each security's profits-tobook by its weight in the portfolio. Dividend yield: The return earned by a stock investor, calculated by dividing the amount of annual dividends per share by the current share price of the stock.
