Weighted Average Life to Maturity: The average time in years to receive the principal repayments. 30 Day SEC Yield: Represents net investment income earned by a fund over a 30-day period, expressed as an annual percentage rate based on the fund's share price at the end of the 30-day period. Option-Adjusted Spread (OAS): The measurement of the spread of a fixedincome security rate and the risk-free rate of return, which is then adjusted to take into account an embedded option.
