The investment objective of the Dimensional Global Real Estate ETF (the "Global Real Estate ETF" or "Portfolio") is to achieve long-term capital appreciation.

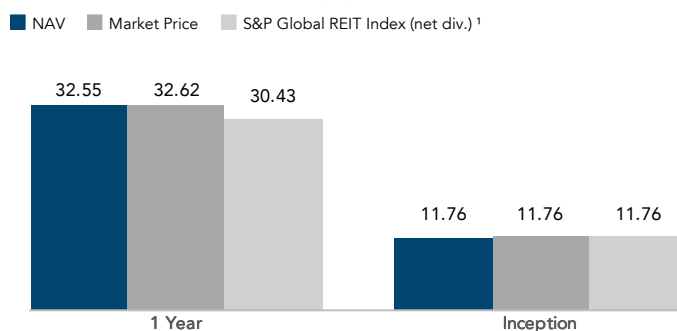
