The investment objective of the DFA Real Estate Securities Portfolio is to achieve long-term capital appreciation.

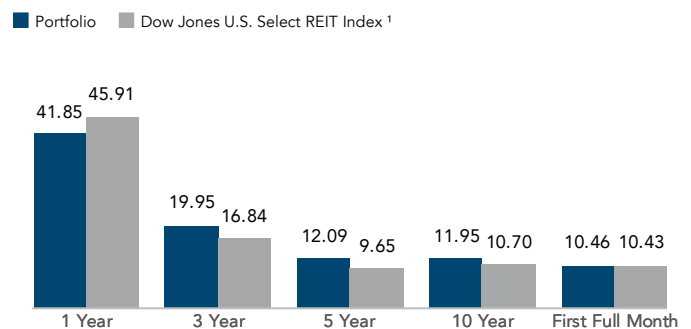
PRINCIPAL RISKS
